**Tennis Rules and Regulations**

1. Allocation of all courts will be at management's discretion.
2. Group captains will be responsible for all collection of payments and for supplying the club with a full list of all regular players prior to the first day of play and will be responsible for their co participants behavior on their court's. Any behavior deemed inappropriate or detrimental to the club or any other club participants enjoyment will result in all tennis and club privileges being terminated without any refund of any kind for both the Captain and or the offending player. The clubs management will alone determine inappropriate behavior and its decision will be final.
3. The child care center will be open daily. (Operating hours vary). All children must remain in the child care center. Children may not be left unattended in any area of the club for any reason.
4. Any unauthorized use of any part of the complex including but not limited to whirlpool, classes, bikes, weight room or any other machinery will result in termination of membership with no reimbursement of monies paid.
5. If a change in group captains is required, the club must receive written notification from the previous group captain and the new group captain shall sign and accept the court reservation contract.
6. No form of instruction will be allowed on the court except as authorized by the club.
7. No ball hoppers and only 3 balls permitted on each court.
8. Absolutely NO dark soled sneakers.
9. The captain accepts the responsibility of informing every player of the rules and the consequences of breaking them.
10. Proper attire is required at all times.
11. No Smoking, no food or beverages allowed on the courts.
12. Players are expected to vacate the court at the conclusion of their paid time period.
13. Players only on the courts! Four players only \* No parents, children or spectators.
14. The use of the facility is strictly at the player's own risk. The club is not responsible for injuries, accidents or damage to personal property arising from normal athletic activities on the premises. All participants or guests of participants hereby specifically waive any claims for damages arising from their use of club facilities.
15. Makeup's will not be given, unless the club closes or if the court time is resold.
16. Reserved lesson courts may only be used with the tennis pro for which the court is held.
17. All tennis players must check in upon entering the club.
18. Players may only use the locker room and lounge area immediately before and after their scheduled court time.
19. The rules and regulations may be changed by management without notification.
20. Court time and any program slot may NOT be resold by any other party other than LifePlex.
21. Make-up dates within season will be issued for Holiday and Inclement weather closures
